

## Privacy policy

### For participants in the study conducted by the ETK One Health Institute of the University of Debrecen at the Campus Festival

The One Health Institute, Faculty of Health Sciences, University of Debrecen, will participate in the Campus Festival, scheduled to take place from July 16 to 20, 2025.

At the event, the One Health Institute will collect microbiological samples from the hands of interested participants as part of a program (hereinafter referred to as the Study) and will send the results to those concerned by email upon request.

The One Health Institute, Faculty of Health Sciences, University of Debrecen, pays special attention to the protection of personal data and ensures transparent data management, the basic requirement of which is providing adequate information about data management.

During participation in the Campus Festival, the One Health Institute, Faculty of Health Sciences, University of Debrecen, provides the following information regarding the organisation and implementation of the event, following the legal provisions governing the protection of personal data, in particular the GDPR:

## Legislation on data processing

The following legal provisions apply to the Data Controller's data processing:

- Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons concerning the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter: GDPR),
- Act CXII of 2011 on the right to self-determination concerning information and freedom of information (hereinafter: Info tv.)

## Data processing carried out by the Data Controller

### 1. Data processing related to registration for the Study

- 1.1. Purpose of data processing:** Participants in the Study can register on site.
- 1.2. Scope of data processed:** name, email address.
- 1.3. Legal basis for data processing:** consent [GDPR Article 6(1)(a) and Article 9(2)(a)].
- 1.4. Duration of data processing:** Until consent is withdrawn, but no later than the end of the event.

## **2. Data processing related to sending the results of the Study**

**2.1.1. Purpose of data processing:** To inform participants in the investigation of the results by email, upon request.

**2.1.2. Scope of data processed:** name, email address.

**2.1.3. Legal basis for data processing:** consent [GDPR Article 6(1)(a) and Article 9(2)(a)].

**2.1.4. Duration of data processing:** Until consent is withdrawn, but no later than the end of the event and/or until the results of the microbiological culture are communicated by email. The bacteria cultured during sampling will not be used for any purpose and will be destroyed at the end of the event or after the culture results have been sent out.

## **3. Taking photos/videos at mass events, editing them for publication, posting them on websites, social media and video sharing sites, using them in PR materials**

**3.1. Purpose of data processing:** to document the participation of the One Health Institute at the Campus Festival and to publish this information, together with accurate and reliable press releases, on the website [www.unideb.hu](http://www.unideb.hu) and the official social media pages of the One Health Institute, Faculty of Health Sciences, University of Debrecen (Facebook, Instagram) and YouTube channel.

**3.2. Scope of data processed:** photos and videos.

**3.3. Legal basis for data processing:** legitimate interest [GDPR Article 6(1)(f)].

**3.4. Duration of data processing:** From the use of the recordings until archiving.

**3.5. Data transfer:** To the University of Debrecen Ildikó M. Tóth Press Centre, which forwards the press release to the media outlets that requested it, with attribution.

## **4. Taking unique photos/videos, editing them for publication, and posting them on websites and social media and video sharing sites**

**4.1. Purpose of data processing:** to document the participation of the One Health Institute at the Campus Festival and to publish this information, together with accurate and reliable press releases, on the website [www.unideb.hu](http://www.unideb.hu) and the official social media pages of the One Health Institute, Faculty of Health Sciences, University of Debrecen (Facebook, Instagram) and YouTube channel.

**4.2. Scope of data processed:** photos and videos.

**4.3. Legal basis for data processing:** consent [GDPR Article 6(1)(a)].

**4.4. Duration of data processing:** From the use of the recordings until archiving.

**4.5. Data transfer:** To UD Ildikó M. Tóth Press Centre, which forwards the press release to the media outlets that requested it, with attribution.

### **Access to data**

Only the staff members of the One Health Institute, Faculty of Health Sciences, UD, who are responsible for the organisation of the Study and are bound by confidentiality, have access to the personal data of the participants.

### **Data security measures**

The Data Controller undertakes to ensure the security of the data, to take the technical measures necessary to ensure that the data recorded, stored and processed are protected, and to do everything in its power to prevent their destruction, unauthorised use and unauthorised alteration. It also undertakes to require any third parties to whom it may transfer or disclose the data to comply with its obligations in this regard. In electronic form, storage takes place on the official, password-protected computers of persons authorised to access the data.

### **Rights of data subjects and rules on the exercise of rights**

#### *Right to information*

Following Article 15(1) of the GDPR, the data subject may request information about the personal data processed by the Data Controller.

#### *Right to request a copy*

Under Article 15(3)-(4) of the GDPR, the data subject may request a copy of the personal data processed by the Data Controller.

#### *Right to correction*

Following Article 16 of the GDPR, we will modify and clarify your personal data in accordance with your request.

#### *Right to restriction*

The data subject may request the restriction of data processing in the following cases:

- if the accuracy of the personal data is contested, we will restrict data processing until the Data Controller verifies the accuracy of the personal data;
- the data processing is unlawful, and the data subject opposes the erasure of the data and requests the restriction of their use instead;
- the Data Controller no longer needs the personal data, but the data subject needs it to establish, exercise or defend legal claims; or
- if you exercise your right to object, we will restrict data processing for the period during which we verify the legitimacy of your request.

#### *Right to protest*

The data subject shall have the right to object, on grounds relating to his or her particular situation, at any time to processing of personal data concerning him or her based on Article 6(1)(e) or (f). In this case, the Data Controller may no longer process the personal data unless the Data Controller demonstrates compelling legitimate grounds for the processing which override the interests, rights and freedoms of the data subject or for the establishment, exercise or defence of legal claims.

#### *Right to erasure*

In the cases specified in Article 17 of the GDPR, the data subject may request that we erase their personal data.

### **Enforcement options**

If, in the opinion of the data subject, the data controller's data processing does not comply with the legal requirements, the data subject may initiate proceedings before the Hungarian National Authority for Data Protection and Freedom of Information (Postal address: 1363 Budapest, Pf.: 9., e-mail address: [ugyfelszolgalat@naih.hu](mailto:ugyfelszolgalat@naih.hu)) or may turn to the courts.
